**1. Property.** Seller hereby agrees to sell to Buyer, and Buyer hereby agrees to purchase from Seller (the "Transaction"), all of Seller's right, title and interest in the commercial real property located at \_\_\_\_\_ [Property address], and the legal description: \_\_\_\_\_ (the "Property").

### **2. Personal Property.**

(A) The sale includes all of Seller's right, title and interest to all real estate, buildings, improvements, appurtenances and fixtures (except as described below). Fixtures shall include all things that are embedded in the land or attached to any buildings and cannot be removed without damage to the Property.
