**An Act Made To Amend And Consolidate Laws Relating To
Procedure of Criminal Cases**

Preamble:

Whereas, it is expedient to make the procedural law simplified and clearly, by amending and consolidating the laws in force relating to procedure in investigation, prosecution, filing, proceeding, hearing and adjudication of criminal cases and other procedures related thereto, and execution of judgments in such cases;

Now, therefore, the Legislature/Parliament enacted as in clause (1) of Article 296 of the Constitution of Nepal has enacted this Act.

Chapter-I

Preliminary

1. **Short title and commencement:** (1) This Act may be cited as the "National Criminal Procedure (Code) Act, 2017".
(2) Section 192 of this Act shall commence on such date as appointed by the Government of Nepal by a notification in the Nepal Gazette, and the other Sections, on 17 August 2018.
2. **Definitions:** Unless the subject or the context otherwise requires, in this Code:
