

Data Processing Agreement for Oracle Cloud Services

1. Scope and order of precedence

This Data Processing Agreement shall be effective for the Services Period of any order placed under the Oracle Cloud Services Agreement.

2. Definitions

"Customer" or "you" means the Customer that has executed the order for Cloud Services.

"Oracle" or "Processor" means the Oracle subsidiary listed in your order for Cloud Services.

"Oracle Affiliates" mean the subsidiaries of Oracle Corporation that may assist in the performance of the Services.

"Model Clause" means the Standard Clause for the Transfer of Personal Data to Processors in Third Countries under Directive 95/46 approved by Commission Decision of February 2, 2019, including Appendices 1 and 2 thereto.

"Personal Data" means any information relating to an identified or identifiable natural person (the subject); an identifiable person is one who can be identified, directly or indirectly, in particular by reference to an identification number or to one or more factors specific to his/her physical, physiological, mental, economic, cultural or social identity.

"The Directive" means Directive 95/46/EC on the protection of individuals with regard to the processing of Personal Data and on the free movement of such data.

3. Categories of personal data and purpose of the Personal Data Processing

In order to execute the Agreement, and in particular to perform the Services on behalf of Customer, Customer authorizes and requests that Oracle process the following Personal Data:

Categories of Personal Data: Personal Data may include, among others, personal contact information such as name, home address, home telephone or mobile number, fax number, email address, and password; information concerning family, identity and social circumstances including age, date of birth, marital status, number of children and name(s) of spouse and/or children; employment details including employer name, job title and function, employment history, salary and other benefits, job performance and other capabilities, education/qualification, identification numbers, social security details and business contact details; financial details; and goods and services provided.
