

CHAPTER 19 PARTNERSHIPS: FORMATION AND OPERATION

Chapter Outline

1. Business organizations that are formed legally as partnerships, although they are not always so called in conversation, are governed throughout their entire existence by the legal contract and accounting partnerships.
 - a. Advantages of the partnership form include ease of creation and the absence of the double taxation often inherent in the limited liability of a corporation structured as business.
 - b. Partnership taxation tends to be a significant one when compared with large corporate organizations, primarily because of the unlimited liability being characteristic of all general partners.
 - c. Partnership legal forms have been created over the years to combine the benefits of corporations and partnerships such as S corporations, limited liability partnerships, and limited liability companies.
2. Partnership accounting and the capital accounts
 - a. The historical aspects of partnership accounting center on the capital accounts maintained by each individual partner.
 - b. The issue of accounting for these capital interests is the matter of partnership agreement about withdrawal procedures, the usual investment, withdrawal, admission of a new partner, retirement of a partner, etc.
 - c. The usual investment made by the partners in the business should be recorded in the capital account in addition to any other assets, however, which is considered to truly constitute part of a particular partner's or an investment firm's share.
 1. In the future, interest and dividends would not be added and recorded. The capital account balance is then divided according to the percentage of the total investment being made by each partner.
 2. In the goodwill method, the amount being contributed and the corresponding percentage of the total capital interest are used to calculate the value of the business and the percentage goodwill is split among partners, recorded as an original asset.
3. Partnership closing situation
 - a. At the end of each fiscal period, the receipts and expenses accounts must be closed out with the resulting netted figure being assigned to the individual capital accounts.
 - b. The method of allocating interest to the capital accounts should be consistent with the nature of partnership.
