Algebraic expressions and equations are fundamental tools in mathematics. They allow us to represent relationships between variables and constants. In this chapter, we will explore how to simplify, solve, and apply these expressions and equations.

## 4.1 Simplifying Algebraic Expressions

The first step in working with algebraic expressions is simplifying them. This involves combining like terms and using the distributive property. For example, the expression  $3x + 2x - 5 + 4$  can be simplified to  $5x - 1$ .

When simplifying, it is important to identify like terms. Like terms have the same variables raised to the same power. For instance,  $3x^2$  and  $2x^2$  are like terms, but  $3x^2$  and  $2x$  are not.

Another key concept is the distributive property, which states that  $a(b + c) = ab + ac$ . This property is used to expand expressions and to factor them. For example,  $2(x + 3) = 2x + 6$ .

Example 1

Consider the expression  $4x^2 + 3x - 2x^2 + 5x + 7$ . To simplify, combine like terms:  $(4x^2 - 2x^2) + (3x + 5x) + 7 = 2x^2 + 8x + 7$ .
