## 1. Uniform Civil Code (UCC)

The Uniform Civil Code (UCC) aims to replace personal laws based on religion or community with a single set of civil laws for all citizens, irrespective of religion, caste, or gender. It covers areas such as marriage, divorce, inheritance, and adoption. The objective of UCC is to promote national integration, equality, and secularism by ensuring all citizens are treated equally before the law.

The idea of UCC is mentioned in Article 44 of the Directive Principles of State Policy in the Indian Constitution. Though not enforceable, it guides the state to strive for a uniform civil law. Supporters believe it upholds gender justice and human rights, while critics argue it may interfere with religious freedoms.

Anyone can file a PIL in the High Court or Supreme Court, even if they are not directly affected by the issue. Common areas include environmental protection, human rights, corruption, and social justice. It has become an essential aspect of judicial activism and accountability.

However, courts have cautioned against the misuse of PIL for personal gain or publicity. PIL must be filed in good faith and with genuine public concern. It remains a powerful democratic tool to uphold rights and promote justice.
