

## AU Section 801 Compliance Audits

Supersedes SAS No. 74E

Source: SAS No. 117

Effective for compliance audits for fiscal periods ending on or after June 15, 2010.  
Earlier application is permitted.

### Introduction and Applicability

**801** Governmental Nonprofit entities establish governmental audit requirements for auditors to challenge or audit all their compliance with applicable compliance requirements. This section is applicable when an auditor is engaged, or required, by law or regulation, to perform a compliance audit in accordance with all of the following:

- Generally accepted auditing standards (GAAS)
- The standards for financial audits under Government Auditing Standards
- A governmental audit requirement that requires an auditor to express an opinion on compliance (SAS part .A1–.A2)

**802** This section addresses the application of GAAS to a compliance audit. Compliance audits usually are performed in conjunction with a financial statement audit. This section does not apply to the financial statement audit component of such engagements. Although certain SAS sections are not applicable to a compliance audit, as identified in the appendix of this section, all AICPA sections other than those cited are applicable to the audit of financial statements performed in conjunction with a compliance audit.

**803** This section is not applicable when the governmental audit requires general audits for an organization, in accordance with Statements on Standards for Accounting Organizations, of an entity's compliance with specified regulatory events or its maintenance of an entity's internal control over compliance. AICPA section 901, *Compliance Auditing*, is applicable to these engagements. If the auditor is required to challenge compliance audit and an indication of internal control over compliance, this section is applicable to performing and reporting on the compliance audit, and AICPA section 904 is applicable to performing and reporting on the maintenance of internal control over compliance. (SAS part .A2)

**804** Sections 206–208 and 903 address audits of financial statements, as well as other kinds of engagements. Sections 204–205 and 500 generally are not adopted in the structure of a compliance audit. However, with certain exceptions, sections 400, 600, 700, and 800 generally cannot be adopted in a compliance audit because they address the auditor's report on an audit of financial statements and other topics that are not applicable to a compliance audit.

**805** The AICPA sections that are not applicable to a compliance audit are listed in the appendix of this section. All of the other AICPA sections are applicable to
