not able to recommend practical implementable solutions that would close the gaps that exist in the digital economy tax administration The findings revealed that BEPS is not a single problem faced by all states but states face different BEPS problems and evaluate them from their own state centred perspectives Hence the development of many interim measures by different states to tax the digital economy as the international community is still trying to come to a consensus on the possible practical solutions The current Kenyan tax framework on taxation of the digital economy is obscure as only recent Bills tabled in Parliament try and address the issue in depth In light of the findings of this research it was established that the problem is not so heavy on laws and regulation on taxation of goods sold electronically but rather implementation of the applicable laws where they exist The paper finally recommends possible amendments to the Kenyan legal framework and the proposed amendments are assessed by means of comparison with what has taken place in other jurisdictions **Other**
